MINUTES

LLANYBYDDER MATTERS

THE PARK

As permission was given to the Clerk at our 28/11/23 meeting to pay Redlynch Leisure (Adventure Playground), the Clerk made 2 payments of £18,615.60 = £37,231.20 as per their Invoice.

Tenders are being prepared for the Playing Field Contracts for Llanybydder and Rhydcymerau parks. A tender is being prepared for the flower contract. They will be displayed in the village and our website.

A Teams meeting was called to discuss a £2000.00 Grant in respect of "Revitalising Rural Town Centre Fund" from Carms CC. The project chosen by our Council was the painting of the frontage of Llanybydder Public Conveniences. As there was a deadline for the Grant application there was no time but to contact Proclean Wales for a quote, which was for Materials £783.13 and Labour £2880.00 = £3663.13. D Owen forwarded documents to the Clerk, received from Carms CC, informing our Council they have approved funding of £2000.00 Grant under the Revitalising Rural Town Centre Fund, which was agreed at our Teams meeting that our Council would pay the difference.
