## LACK OF FACILITIES FOR YOUNGSTERS IN THE VILLAGE & THE PROBLEM OF BOY RACERS

Reply received from Charles Weller. PCSO Eleri is temporarily employed elsewhere. He did ask for car registration numbers to progress this enquiry. Clerk is to contact PS Weller again and report more regular problems with the boy racers. There have been complaints that boy racers speed all through the village in Llanybydder. They now use the whole village for racing from 5pm – 12pm and sometimes in the afternoons. In the RFC car park, they disturb residents late at night with their loud revving, wheel spinning and shining their headlights on to houses. All this happens after 11pm at night which is a terrible disturbance.
