MINUTES

LLANYBYDDER MATTERS

THE PARK

Clerk is to write to the Legal Dept, Carms CC in respect of Mr Garside, and to send all relevant correspondence in relation to this matter to them.

The completed fully executed Deed of Variation to Lease for Llanybydder Recreation Ground was received from the Head of Administration & Law for safekeeping.

A lengthy reply was received from Nicola Smith, Transport Policy & Programme Officer. This matter has all to do with prioritisation. Such requests of this nature make a far greater call on their resources than budgets can realistically deliver. The Prioritised List is periodically reviewed to consider new scheme requests as well as existing requests. The B4337 is already on a footway provision request and has not been included in their forward rolling Capital improvements programme. The B4337 remains on their records in the event of alternative funding sources.
